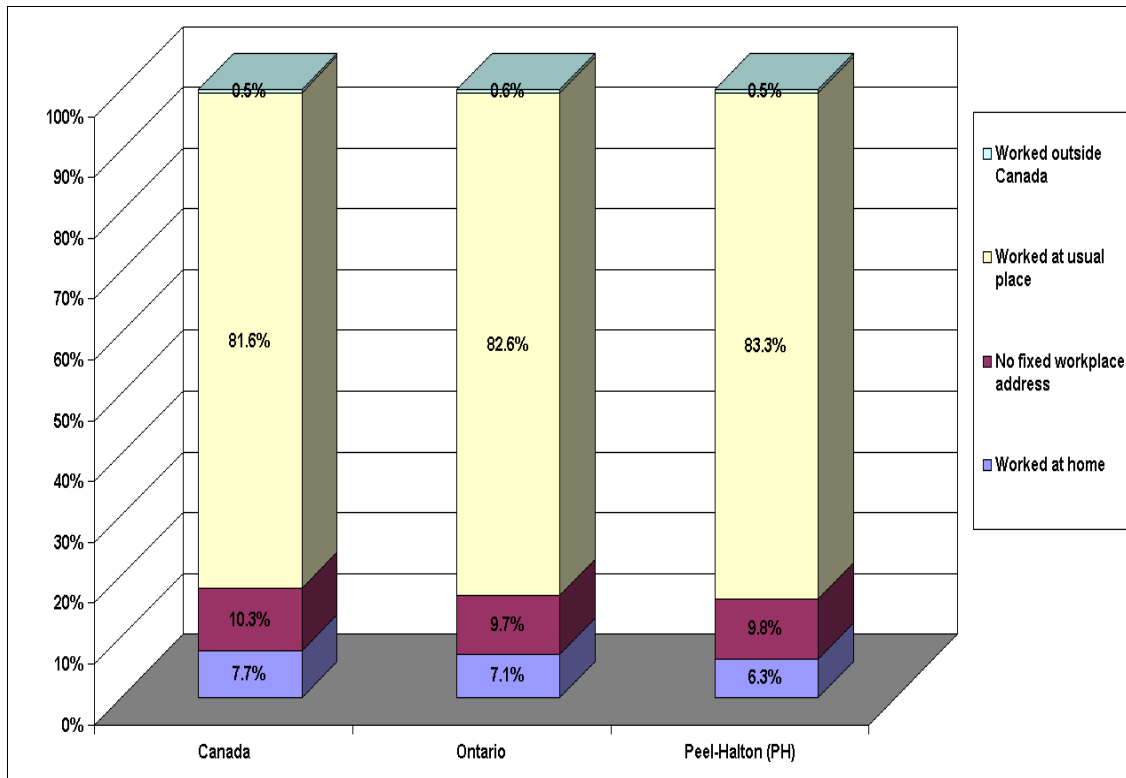
## Place of Work Status

This newsletter provides the place of work status for the Peel Halton (PH) residents by using official data from the 2006 Census of Canada. According to Statistics Canada, the place of work status refers to the classification of people aged 15 or over who worked at some point between January 1, 2005 and May 16, 2006 (Census Day). The place of work status includes people aged 15 or over worked at home, worked outside Canada, had no fixed workplace address, or worked at a specific address. ### Highlights for the Peel-Halton Area

- ◆ In PH, 6.3% of employed labour force aged 15 years and over reported worked at home.
- ◆ In PH, 0.5% of the employed labour force, aged 15 years and over reported that they worked outside Canada in 2006.

## Did you know?

### How many people in PH worked at home in 2006?

In 2006, about 53,245 people reported working at home in PH. They made up 6.3% of all workers aged 15 years and over. The comparative figures for Ontario and Canada were 7.1% and 7.7% , respectively.

### How many people in PH worked outside Canada in 2006?

In PH, 4,495 people, or 0.5% of the employed labour force, reported that they worked outside Canada in 2006. In Ontario and Canada, the proportions were 0.6% and 0.5%, respectively.
